ELIGIBILITY CRITERIA AND OTHER TERMS & CONDITIONS

The University of Agricultural Sciences Bangalore proposes to set up an Biofertilizer Production Unit in the Department of Agricultural Microbiology on a Public Private Partnership for commercial production and widespread application of biofertilizer. Hence, UASB invites **Expression of Interest** from Reputed Service Providers who meet the criteria described below: -

- i. Private Partners such as Co-Operative societies, Non- Governmental Organizations, Federation of Self-Help Groups, Private Companies *etc* are eligible to apply.
- ii. Private Partners having license for marketing of biofertilizer are only eligible for consideration.
- iii. Interested parties should apply with their credentials and also indicate for any other facilities that they would provide.
- iv. The period of contract would be initially for a period of two years, which may be extended on mutual acceptance and based on performance.
- v. The selected service provider shall be primarily responsible for marketing of the products with the active support of UASB.
- vi. The Interested parties are requested to submit their 'Expression of Interest' in the format appended herewith along with the necessary documents as listed. Incomplete applications would automatically be rejected.
- vii. The EOI shall be liable for rejection in the absence of requisite supporting documents against each of the applicable requirements. The proposals would be evaluated on the basis of their interest, experience in social mobilization, marketing of products of the state and submission of application form with supporting documents (complete).
- viii. Evaluation of the submitted EOIs falls under the sole discretion of UASB, which may choose to apply whatever conditions it deems appropriate during the evaluation for engagement/discontinuation of the service provider.
