#### III. ACADEMIC ELIGIBILITY:-

Masters' Degree: Candidates should possess a Bachelor's Degree with a minimum OGPA of 5.50/10.00 or its equivalent from any recognized State/Central/Deemed Agricultural/Horticultural/Forestry Universities & other Farm Universities.

**Doctoral Degree:** A Master's Degree in the concerned subject or eligibility criteria furnished below (given by the respective universities) or an equivalent qualification from recognized State/Central/Deemed Agricultural/Horticultural/Forestry Universities & other Farm Universities in terms of equivalent course duration with minimum OGPA of 7.50/10.00 (for semester system) to be eligible to seek admission.

# IV. DURATION, MEDIUM OF INSTRUCTION, SYSTEM OF EDUCATION OF DEGREE PROGRAMMES:

Master's Degree including MBA (ABM): A minimum of two academic years (4 Semesters) shall ordinarily be required for the completion of course work, Research, Thesis/Project Report preparation and Examinations leading to the award of Master's degree.

**Doctoral Degree:** A minimum period of three academic years (6 Semesters) shall be required for completion of the Ph.D. degree programme

System of Education & Medium of Instruction: All the Masters & the Doctoral degree programmes are taught under semester system in English medium only

- V. PROCEDURE FOR ADMISSION: The admission committee will prepare the list of eligible candidates based on merit considering the eligibility prescribed for admission and recommend to the University for necessary approval, and upon approval, the Registrar will notify the same and communicate to the Candidates. The academic regulations pertaining to Master's degree programme are also applicable for students admitted under NRI quota
- VI. RESERVATION OF SEATS: The seats shall be reserved in favour of NRI/Children of NRI/ NRI sponsored candidate well within the existing 10% over and above the intake of the respective Degree programmes, not exceeding one student per Department (Except MBA (ABM) degree programme). Admission will be made as per the recommendations of the P.G. Admission Committee based on the merit of the candidates in the given discipline. However, the University has the right to decide number of seats for NRI Quota under each Department based on need and facilities available and not exceeding the total seats notified

# VII. FEE TO BE PAID BY THE CANDIDATE AT THE TIME OF JOINING THE DEGREE PROGRAMME:

NRI sponsored candidate shall pay Institutional Economic fee of US \$ 4000/-(four thousand dollars only) for Master's Degree/ MBA (ABM) and US \$ 5000/- (five thousand dollars only) for Ph.D. degree programme (for every year) along with Regular semester fee for M.Sc. (Agri.)/MBA (ABM) & Ph.D., as prescribed by the University from time to time

**NOTE:** a. The Fees prescribed may change from time to time

b. One US \$ is equivalent to the rate existing on the date of payment

- 1. He / She shall pay Health Insurance premium as prescribed from time to time. If the candidate is required to stay for more than the prescribed duration to complete the degree, he/she shall pay the Institutional Economic fee and other fees/charges as prescribed for every year.
- 2. The candidate will be exempted from payment of Institutional Economic fee after the prescribed duration to complete the degree if he/she is expected to complete the degree programme within one semester after the prescribed duration to complete the degree, i.e., the first semester following the prescribed academic period.
- 3. If the Candidate admitted under NRI quota fails to complete the PG degree within the prescribed semesters, 25% of the Institutional Economic fee shall be paid every year, apart from semester fees, till the completion of the degree as per academic regulation of PG degree programmes.
- 4. Rs.1,500-00 towards students Aid Fund /Group Health Insurance shall be paid by each Candidate every year.
- 5. The Candidate has to pay the applicable other fees, applicable, if any.

#### VIII. APPLICATION AND FEES:

Application (PDF) has to be downloaded from the University Website: www.uasbangalore.edu.in from 12.09.2024 to 10.10.2024.

The duly filled-in application along with the Photocopies of educational documents and Notarized Affidavit of the Undertaking by the Parent and the candidate, & Sponsoring copy, including Physical Fitness certificate from Govt. Hospital, DD for Rs.2500/- (Rupees Two thousand five hundred only) towards Application fee drawn in favour of Comptroller, UAS, GKVK, Bengaluru-65, shall be submitted to the Registrar, UAS, GKVK, Bengaluru-65 by post or personally on or before 10.10.2024 during office hours on working days (Monday to Friday from 8.30 am to 4.00 pm and on Saturday from 8.30am to 12.30 PM). The Demand Draft should be purchased during the period from 12.09.2024 to 10.10.2024 only

#### IX. Undertaking:

- 1. The Parent and the Candidate are required to give an undertaking on Stamp Paper (Rs.100/-) notarized from the residing State / Country where the candidate & the Parent are living (depending upon the address of the Candidate & the Parents) should be enclosed (Annexure I).
- 2. An Undertaking by the Sponsorer on Stamp Paper (Rs.100/-) or equivalent currency in the sponsorer country, notarized from the foreign country or India where the sponsorer is living (depending upon the address of the sponsorer country) should be enclosed (Annexure II).

#### NOTE:

- \* Notarized undertaking obtained after the last date prescribed for submission of filled in applications will not be considered
- \* Definition of NRI candidate/NRI sponsored candidate shall be as given by GOI/KEA
- \* The University reserves the right of admission of the candidates and it is at the sole discretion of the University to increase or decrease the number of seats under each discipline depending on situation.

#### **CONDITIONS:**

- 1. The admission is governed by Govt. Orders / UAS(B) regulations issued from time to time.
- 2. The application is liable to be rejected due to delayed submission, Incomplete application and no payment of prescribed fees.
- 3. No. of seats notified under this Notification is subject to alteration and the University reserves the right to fill-in / not to fill-in any or all the seats notified, not exceeding the total seats notified. However, the decision of the Admission Committee is final.
- 4. Furnishing any false information in the Application form shall hold the candidate liable to action deemed fit.
- 5. The prescribed fees paid by the Candidates /concerned will not be refunded by the University under any circumstances, once admitted or registered.
- 6. The NRI seats shall be allotted considering purely on Merit basis for Master's and Doctoral degree programmes.
- 7. The decision of the Admission Committee of the University shall be final in this regard.

#### XI. GENERAL INSTRUCTIONS:

- 1. After the last date of submission of filled-in application, list of eligible Candidates, merit list, selected list and last date for admission will be uploaded in the University Website.
- 2. On receipt of selection letter, the Candidates shall confirm his / her willingness to join the degree programme in writing for which he / she has been provisionally selected for admission. No change of subject / campus is entertained, subsequently.
- 3. The University will not own the responsibility of Candidate's involvement in any unlawful activities during the period of his / her study, and candidate himself / herself is solely responsible to appear for any enquiry by the police.
- 4. Confirmation of admission is subject to verification and correctness of all Original Transcripts /Certificates, of Prescribed Fees and fulfilment of all other admission requirements by the authorities concerned.
- 5. Payment should be made only in US dollars or equivalent Indian rupees.
- 6. College and Degree Programme will be allotted based on merit and / or by option to respective campus including Mandya Campus and the seats available in a particular college as per the seat matrix issued by the University.

The I Semester of the Post-Graduate Degree Programmes (Master's) of the University for the academic year 2024-25 will be commenced from 20.11.2024, while for Ph.D. degree programmes from 16.12.2024 (tentatively) respectively. The candidate must to the Registrar, UAS, Bangalore on or before the date of commencement of the Semester.
